

Integrated approach
Involve Roma
Target excluded Roma
Address specific local needs
Address barriers to provision & use of services
Anticipate end of EU funding





COUNCIL OF EUROPE



1st principle: integrated approach

- education, employment, healthcare, housing & social services
- interrelated issues, causes & solutions
- issues in wider context
- responsibility of local authorities
- avoid shopping list of activities without strategy





2nd principle: involve Roma

- Roma know what they need, why, what are the barriers, what can be done, what is affordable & sustainable
- Roma participation → community ownership
 → sustainability
 - but also participation of non-Roma
 - →support
 - →avoid stigmatization of Roma
 - →cooperation





3rd principle: target excluded Roma

- excluded & disadvantaged Roma, not just Roma
 - to avoid negative perceptions
 - "Roma receive more than their share"

4th principle: address specific local needs

- adapt strategy to municipality
 - same need in 2 different municipalities
 - different causes
 - different solutions

5th principle: address barriers to provision & use of services

- "if you build it, people will come"
- awareness
- affordability
- negative experience

6th principle: anticipate end of EU funding

plan transition to local/national funding

ACT 1 Understand need to tackle marginalisation

- need commitment of Mayor & Local Council
- arguments
 - marginalisation

 criminality, breakdown of social cohesion for all
 - inclusion

 better overall public services,
 increase in real estate value, new residents,
 investors, from welfare to taxpayers
- formal commitment
 - written decision of Mayor / Local Council







ACT 2 Appoint Coordinator

- Coordinator
 - high level member of municipal staff
 - responsible for managing/monitoring ROMACT process
 - reports to the Mayor

ACT 3 Contract Facilitator

- Facilitator
 - not municipal staff
 - contracted & empowered by municipality
 - does not represent municipality or Roma
- capable of
 - mediating between all stakeholders
 - providing coaching







ACT 4 Map stakeholders

- "who is who" & "who does what"
- done & constantly updated by Facilitator
- ROMACT stakeholder map template

ACT 5 Set up Municipal Taskforce for Roma Inclusion

- Coordinator helped by Facilitator sets up Municipal Taskforce for Roma Inclusion - with approval of Mayor & Local Council
 - representatives of municipal departments & other local institutions
 - Roma representatives (CAG)
 - NGOs, CSOs, etc.
 - Coordinator
 - Facilitator





Definition - Municipal Taskforce **ROMAC** for Roma Inclusion


- min. 1 meeting/month
- chaired by Coordinator
- secretariat by Facilitator

training in communication/cooperation recommended

ACT 7 Decide on where to intervene

- Municipal Taskforce to select which neighbourhoods to target
 - demographic information (total population, population at risk of poverty, estimated Roma population)
 - poorest areas (geographical name, streets or bordering streets, etc.)
- ROMACT Baseline Survey template
- Mayor (& local Council) formally decide



ACT 8 Assess capacities of municipality




 ROMACT Municipality Capacity Assessment template

ACT 9 Carry out Community Needs Assessment



- needs + barriers!
 - root causes of poor outcomes
- → demands & proposals to municipality
- demands & expectations of whole roma community
- Facilitator "facilitates"
- ROMACT Community Needs Assessment template







ACT 10 Draft Community Priorities List

- CAG with help of Facilitator drafts Community Priorities List
 - list of concrete actions requested by community
 - ✓ if needed, training by Facilitator: how to translate needs & barriers into priorities
- stage 1: prioritize needs & actions
- stage 2: review options & trade-offs
- stage 3: drafts Community Priorities List
 - what should be done, by whom, by when & how





STEP 3: translating community priorities list into concrete measures & projects

- ACT 11 Develop & adopt Joint Action Plan for Roma inclusion
- ACT 12 Implement short & medium term actions
- ACT 13 Integrate Roma issues in Local Development Plan / Strategy
- ACT 14 Prepare concrete actions







ACT 11 Develop & adopt Joint Action Plan for Roma inclusion

- drafted by Municipal Taskforce
 Community Priorities List
 Municipality Capacity Assessment
- NB: or adapt existing Action Plan
- short term actions by Roma or municipality
- short/medium term actions using local budget
- longer term actions in Local Development Plan with national/EU funding
- to be approved by Mayor / Local Council







ACT 12 Implement short & medium term actions

- own resources
- implemented by Roma community or municipality
- important for showing ROMACT contribution
- Facilitator helps Roma community take ownership of its actions





ACT 13 Integrate Roma issues in **ROMACT** Local Development Plan/Strategy

- Roma Taskforce integrates
 - Joint Action Plan/upgraded Action Plan for Roma Inclusion
 - →Local Development Strategy / Development Plan
- rather "Local Development Strategy" than segregated in separate "Roma strategy"







ACT 14 Prepare concrete actions

- municipality implements Local Development Plan
 - including content from Joint Action Plan
- issues
 - affordability
 - opportunity
 - safety, dignity & reputation
- need to consult CAG
- Facilitator moderates meetings between administration & CAG





STEP 4: funding, implementing ^{RO} & monitoring



- ACT 16 Implement actions
- ACT 17 Monitor & evaluate implementation of actions with CAG

ACT 15 fund actions

- if possible use local resources
- using national or EU funding may be necessary but often challenging
- Facilitator
 - informs about funding opportunities
 - identifies experts in EU funding

• Facilitator informs the CAG







ACT 16 Implement actions

- municipality often responsible for implementing actions
- but it needs:
 - to inform the CAG
 - to involve the whole Roma community

ACT 17 Monitor & evaluate implementation of actions with CAG

- for each action
 - what will be monitored & how
 - who will be in charge of collecting information
 - who will be informed
- with the CAG



Structure of the Programme NW Romania











Structure of the Programme Romania










